Purpose of award:

This form alone will be used by the Board of Trustees in determining individuals to receive the Award, and, therefore, should be filled in as completely as possible. The recipients will be determined by August 31, 2020.

Method of award recipient selection:

The President of the Board will appoint a Selection Committee to review all nominations and recommend a slate of candidates to the full membership of the Board of Trustees.

Announcement and recognition:

Following the selection of recipients, a public announcement will be made. The awards are presented on the occasion of the Alumni Homecoming luncheon, typically held in October of each year.
